# SCHEME FOR FINANCIAL ASSISTANCE TO A REGISTERED BENEFICIARY IN CASE OF ACCIDENT

Under the provision of Section 22(1) Rule 274 of the Building & Other Construction Workers (RE&CS) Act, 1996 and Rule framed there under, the scheme for financial assistance to a registered beneficiary in case of accident is hereby made as follows.

**1. Name of the Scheme:-**

Scheme for financial assistance to a registered beneficiary in case of accident.

**2. Eligibility:-**

A registered Building & Other Construction Workers under the Board is eligible to get financial benefit under the scheme.

**3. Objective of the Scheme:-**

To give financial assistance to the Beneficiary who is hospitalized for 3 or more days due to an accident or met with an accident and put in a plaster at residence for 3 or more days or become disable due to the accident.

**4. How to apply:-**

The registered beneficiary will submit an application in prescribed form to the Secretary through Chief Labour Officer/Labour Officer of the District to which he belongs. The application shall be supported with a medical certificate from the Medical Officer of the hospital/place of treatment stating the accidental hospitalization of the applicant (beneficiary) of the percentage of disability due to accident as the case may be and also be supported with last challan copy in duplicate and Identity card in Xerox of the registered beneficiary. The application shall be submitted within 3 months from the date of release from the hospital or occurrence of disability, as the case may be.

**5. Amount of Financial Assistance:-**

The amount of Financial assistance that will be sanctioned by the Board.

(i). For the first three days of the hospitalization/plastering and amount of ₹ 1,500/- and ₹ 200 per day for the remaining days subject to a maximum of ₹. 5000/-

(ii). In case referral within the state for grievous injury an amount of ₹ 15,000/- and outside of the state ₹30,000/-

(iii). Out of the amount involved for referral cases 50% of the amount shall be paid in advance on submission of the application by the applicant along with the referral slip.

**6. Mode of payment :-**

The payment should be made through the Tripura Gramin Bank (DBT) to the applicant.

7. **Ineligibility**:- If any registered beneficiary is covered under Group Insurance Scheme on life by the Board.
