SCHEME FOR MEETING MEDICAL EXPENSES FOR TREATMENT OF MAJOR AILMENTS.

Annexure- I

In accordance with Section 22(1)(f) of the Building And Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 and Rule 280 of the Tripura Building And Other Construction Workers (Regulation of Employment And Conditions of Service) Rules, 2001 and amended in 2006, the scheme for meeting medical expenses for treatment of major ailments of a beneficiary or his/her dependents is hereby made as follows :-

(i) **NAME OF SCHEME :-**

Scheme for meeting medical expenses for treatment of major ailments of a registered beneficiary or his/her dependents.


(ii) **ELIGIBILITY :-**

A registered beneficiary or his/her dependents suffering from (i)T.B, (ii)Cancer, (iii)Heart Disease, (iv)Kidney Disease, (v) Eye Disease, (vi) Leprosy, (vii)Nerve Disease, (viii) Stomach Ulcer, (ix) Gallbladder Stone, (x)Lever Disease, (xi) Prostate Gland ,(xii) Gynecology and (xiii) Orthopedic will be eligible to get financial assistance for medical treatment under this scheme.

(iii) **HOW TO APPLY :-**

The registered beneficiary may apply for financial grant for medical treatment in prescribed application form (Form-XL) addressed to the Secretary, Tripura Building and Other Construction Workers Welfare Board, Office Lane, Agartala through the concerned District




Labour Officer. The application should be supported by a Medical Certificate in original issued by the Medical Officer working in Government Hospital/ Dispensary.

(iv) AMOUNT OF FINANCIAL GRANT :-

The Board may sanction a maximum amount of ₹ 5,000/- (Rupees five thousand) only or actual expenses whichever is lower per annum to a beneficiary towards medical expenses for the treatment of beneficiary or his/her dependents suffering from (i) **T.B**, (ii) **Heart Disease**, (iii) **Eye Disease**, (iv) **Leprosy**, (v) **Nerve Disease**, (vi) **Stomach Ulcer**, (vii) **Gallbladder Stone**, (viii) **Liver Disease**, (ix) **Prostate Gland**, (x) **Gynecology** and (xi) **Orthopedic**. However, when an operation is involved for the treatment of these diseases the Board may sanction a maximum amount of ₹ 30,000/- (Rupees thirty thousand) only or actual expenses whichever is lower.


The Board also sanctions a maximum amount of ₹ 20,000/- (Rupees twenty thousand) or actual expenses whichever is less per annum to a beneficiary towards medical expenses for the treatment of beneficiary or his/her dependents suffering from (i) **Cancer**, and (ii) **Kidney Disease**. However, when an operation is involved for the treatment of these diseases the Board may sanction a maximum amount of ₹ 50,000/- (Rupees fifty thousand) only or actual expenses whichever is lower.
