NOTIFICATION

Whereas a draft of certain Rules further to amend the Tripura Shops & Establishments Rules, 2000 was published, as required by sub-section (1) of Section 25 of the Tripura Shops & Establishments Act, 1970 in the extraordinary issue dated September 26, 2000 AD under the Notification of the Government of Tripura in the Department of Labour No. F. 24(1)-LAB/ENF/SE/89/9954 dated the 12th September 2000 inviting objections and suggestions from all persons likely to be affected thereby till the expiry of a period of 30 days from the date of publication of the said Notification; And, whereas, the copies of the said Gazette Notification were made available to the public on the 12th September, 2000; And whereas no objections and suggestions received from such persons within stipulated time.

Now, therefore, in exercise of the powers conferred by Section 25 of the said Act, the State Government hereby makes the following amendment in the Tripura Shops & Establishments Rules, 2000 namely :

1. These rules may be called the Tripura Shops & Establishments (Fourth Amendment) Rules, 2000. They shall come into force on and from the date of publication of the Gazette.

2. For schedule 1 appended to the Tripura Shops & Establishment Rules, 1970 (hereinafter referred to as the Principal Rules) the following schedule shall be substituted :
