NOTIFICATION

Whereas a draft amendment to amend the Tripura Inter-State Migrant Workmen (Regulation of employment and Conditions of Service) Rules, 1980 was published as required by Sub-Section (I) of Section 35 of the Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Act, 1979 (30 of 1979) inviting objection and suggestion from all person likely to be affected there by till the expiry of 30 days from the date of publication of the said Notification and whereas the copies of said gazette notification where made available to the public on the 18th July, 1990.

As whereas no suggestion and objection have been received from the public ;

Now, therefore, in exercise of the powers conferred by Section 35 of the said Act, the Government of Tripura makes the following amendment in the Tripura Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules 1980 namely :—

1. (1) These rules may be called the Tripura Inter-State Migrant Workmen (Regulation of Employment and Conditions of Services) (Amendment) Rules, 1989.

(2) They shall come into force with effect from the date of their publication in the official Gazette.

2. In the Tripura Inter-State Migrant Workmen (Regulation of Employment and Conditions of Service) Rules, 1980 (hereinafter called the Principle Rules), for rule 12, the following rule shall be substituted, namely :—

12(1) Fees :— The fees to be paid for the grant of certificate of registration of an establishment under Section-4 shall be as specified below ;

If the number of Migrant Workmen proposed to be employed the establishment on any day —

a) is 5 but does not exceed 50	— Rs. 250/-
b) exceeds 50 but does not exceed 200	— Rs. 500/-
c) exceeds 200	— Rs. 1000/-

(2) The fees to be paid for the grant of licence under Section 7 shall be as specified below :—

If the number of Migrant Workmen recruited or employed by the Contractor or any day—

a) is 5 but does not exceed 50	—Rs. 50/-
b) exceeds 50 but does not exceed 100	—Rs. 100/-
c) exceeds 100 but does not exceed 200	—Rs. 200/-
d) exceeds 200	—Rs. 300/-

(3) In the Principle Rules,

i) in clause (ii) of sub-rule (1) of Rule 18, for the words and figures "Rs. 25/-" the words and figures Rs. 100/- shall be substituted.

ii) in sub-rule (2) of Rule 20, for the figures "087" the figures "0230" and for the figures and words "843- Civil Deposit—Security Deposits" the figures, words and brackets "8443-Civil Deposit (Security)" shall respectively be substituted.
