ADDENDUM

WHEREAS the draft of the Tripura Contract Labour (Regulation and Abolition) (Amendment) Rules, 1993, were published as required by section 35 of the Contract Labour (Regulation & Abolition) Act, 1970 (37 of 1970), at pages-5 & 6 of the Tripura Gazette, Extraordinary issue, dated the 18th December, 1993, under the notification of the Government of Tripura in the Department of Labour NO. F. 16(1)-LAB/ENF/CL/92/10, 335 dated the 9th November 1993, inviting objections and suggestions from all persons likely to be affected thereby till the expiration of 6(six) weeks from the date of publication of the said notification in the official Gazette ;

AND, WHEREAS, the said Gazette was made available to the public on the 18th December, 1993 ;

AND, WHEREAS, no objection and suggestion has been received from the public on the said draft ;

AND, WHEREAS, in exercise of power conferred by section 35 of the Contract Labour (Regulation & Abolition) Act, 1970 (37 of 1970), the State Government made rules and amended the Tripura Contract Labour (Regulation & Abolition) Rules 1978 by a notification NO. F. 16(1)-LAB/ENF/CL/92/17,610-13 dated 10th October 1994.

AND, WHEREAS, it was proposed by Notification NO. F. 16(1)-LAB/ENF/CL/92/10,335 dated 9. 11. 93 to amend the provisions of sub-rule (1) and (2) of Rule 20 and sub-rule (6) and (7) of Rule 26 of the Tripura Contract Labour (Regulation & Abolition) Rules 1978 but due to inadvertence the proposed amendments of sub-rule (2) of Rule 20 of Tripura Contract Labour (Regulation and Abolition) Rules 1978 has not been incorporated in the Notification NO. F. 16(1)-LAB/ENF/CL/92/17,610-13 dated 10th October, 1994.

NOW, therefore, in the Notification NO. F. 16(1)-LAB/ENF/CL/92/17,610-13 dated 10th October 1994, after sub-rule (1) of rule 20 the following shall be added, namely :—

- (2) The fees to be paid for the grant of License under section 12 shall be as specified below :—

If the number of workmen employed by the Contractor on any day—

(a) is 5	Rs. 5.00
(b) exceeds 5 but does not exceed 10	Rs. 50.00
(c) exceeds 10 but does not exceed 20	Rs. 100.00
(d) exceeds 20 but does not exceed 50	Rs. 200.00
(e) exceeds 50 but does not exceed 100	Rs. 300.00
(f) exceeds 100 but does not exceed 200	Rs. 400.00
(g) exceeds 200	Rs. 500.00
