#### NOTIFICATION

Whereas the draft Rules further to amend the Tripura Contract Labour (Regulation and Abolition) Rules, 1978, which the Government of Tripura proposed to make, in exercise of the powers conferred by Section 35 of the Contract Labour (Regulation and Abolition) Act, 1970( No. 37 of 1970);

And whereas the draft Rules namely, the Tripura Contract Labour (Regulation and Abolition) (Fourth Amendment) Rules,2020 were published vide Notification of the Government of Tripura, Labour Department, in the Tripura Gazette Extra Ordinary Issue dated 1\* January,2021 as required by sub-section (1) of the said section, for the information of all persons likely to be affected thereby;

And Whereas, the copies of the said Official Gazette were made available to the public on the 1° January,2021;

And whereas, no objections or suggestions were received from public on the said draft rules;

Now therefore, to achieve the aforementioned purpose, the State Government, in exercise of the powers conferred by Section 35 of the Contract Labour (Regulation and Abolition) Act, 1970 (Central Act No.37 of 1970), hereby makes the following rules, namely:-

#### RULES

 (1) These rules may be called the Tripura Contract Labour (Regulation and Abolition) (Fourth Amendment) Rules, 2020.
(2) They shall come into force on the date of final publication in the Official Gazette.

**2.** In the Tripura Contract Labour (Regulation and Abolition) Rules, 1978 (herein after referred to as the Principal Rules), in rule 12,-

(i) in sub-rule(1),-

(a) the words "in triplicate", shall be omitted;

- (b) for the words "to the registering Officer of the area in which the establishment sought to be registered is located", the words "online on the Shram Suvidha Portal of the Labour Directorate or any other webportal notified by the Government of Tripura," shall be substituted;
- (ii) for sub-rule(2) the following sub-rule shall be substituted, namely:-

"(2) The payment of fees for the registration of the establishment referred to in sub-rule (1) shall be made through e-payment".;

- (iii) sub-rule(3) shall be omitted;
- (iv) for sub-rule (4), the following sub-rule shall be substituted, namely:-

"(4) On submission of e-application referred to in sub-rule(1) by the applicant, an automated acknowledgement shall be generated electronically on the web – portal specified in the said sub-rule."

### 3. In the principal rules, in rule13, -

(i) for sub-rule(1), the following sub-rule shall be substituted, namely:-

"(1) The certificate of registration granted under sub-section (2) of section (7) and generated electronically on the web-portal shall be in Form I annexed to the "Tripura Rationalization of Forms and Reports under Certain Labour Laws Rules, 2019"

 (ii) in sub-rule (3), for the words "to the registering officer", the words, figures and brackets "online on the web-portal specified in sub-rule (1) of rule 17" shall be substituted;

#### 4. In the principal rules, in rule 14,-

in sub-rule(1),-

- after the words "a sum which, together with the amount already paid by such principal employer, would be equal to such higher amount of fees payable", the words "by e-payment" shall be inserted;
- (ii) the words "and to produce the treasury receipt showing such deposit" shall be omitted;

#### 5. In the principal rules, in rule 15,-

- (i) in sub-rule(1),-
  - (a) the words "in triplicate", shall be omitted;

- (b) the words "to the licensing officer of the area in which the establishment, in relation to which he is the contractor, is located" shall be omitted
- (ii) in sub-rule (2), for the words "accompanied by a", the words "accompanied by uploading a copy of the", shall be substituted;
- (iii) sub-rule(3) shall be omitted;
- (iv) for sub-rule (4), the following sub-rule shall be substituted, namely:-

"(4) On submission of e-application referred to in sub-rule (1) by the applicant an automated acknowledgement shall be generated electronically on the web – portal specified in sub-rule(1) of rule 12".

(v) for sub-rule (5), the following sub-rule shall be substituted, namely:-

"(5) The deposit of security at the rates specified in rule 18 and the payment of fees at the rates specified in rule 20 in respect of application referred to in sub-rule (1) shall be made by e-payment";

6. In the principal rules, in rule 17, in clause (ii) of sub-rule (2), after the words "communicated to the applicant", the words brackets and figures "online through web-portal specified in sub-rule (1) of rule 12" shall be inserted;

### 7. In the principal rules, in rule 18,

in sub-rule (2) for the words "in the local treasury", the words "by e-payment" shall be substituted;

#### 8. In the principal rules, in rule 20,

- (i) in sub-rule (1) after the words "fees to be paid", the words "by e-payment" shall be inserted;
- (ii) in sub-rule (2) after the words "fees to be paid", the words "by e-payment" shall be substituted;

#### 9. In the principal rules, in rule 22,-

- (i) in sub-rule (3), in clause (i), for the words "to furnish a treasury receipt" the words "by e-payment," shall be substituted;
- (ii) in sub-rule (3), in clause (ii) for the words "on the applicant furnishing the requisite treasury receipt", the words "on payment of the requisite amount by the applicant through e-payment" shall be substituted.

 (iii) in sub-rule (4), after the words "to the applicant", the words, figures and brackets "online through the web-portal specified in sub-rule(1) of rule 12" shall be inserted;

#### 10. In the principal rules, in rule 23,-

(i) for sub-rule (1) the following sub-rule shall be substituted, namely:-

"(1) Every contractor shall apply online through the web-portal specified in sub-rule(1) of rule 12 for auto-renewal of licence on paying renewal fees by e-payment";

(ii) in sub- Rule (2), the words "in triplicate" shall be omitted.

#### 11. In the principal rules, Rule 26 shall be omitted.

#### 12. In the principal rules, in rule 70,-

(i) for sub-rule (1) the following sub-rule shall be substituted, namely:-

"Every employer and contractor shall upload a unified annual return online, in Form XXIV, on or before the 1<sup>st</sup> day of January every year on the webportal specified in sub-rule(1) of rule 12, giving information as to the particulars specified in respect of the preceding year";

(ii) sub-rule(2) shall be omitted.

# 13. In the principal rules, for the Form XXIV the following Form shall be substituted:
