

Eligibility of the Supplier engaged in selling of retail laboratory materials for the purpose of submission of bid under O/o the CEO, TESI Society, Office Lane, Agartala, Tripura (W).

1. The shop of the Laboratory procurements should be located within Agartala **Municipal Corporation area**. The articles to be supplied and delivered to the ESI Dispensary, Shyamalibazar, Agartala, Tripura (W).
2. He should be a bonafied supplier with valid **Trade License and GST/CGST/Registration/Tin no. /CST certificate/etc.**
3. He should maintain a good stock of laboratory materials of reputed Companies. In case non-availability of the requisitioned articles, he should arrange to supply immediately at his own initiative and cost.
4. The supplier should abide by the procedure to be adopted by the Tripura ESI Society Authority.
5. Bills for supplied chemical re- agent & non re- agent items may be raised in the **1st week** of every month for arranging necessary payment subject to availability of Tripura ESI Society fund.
6. The present agreement is valid for a period of **2 (two) years**, which may be renewed for a further period subject to **satisfactory performance**. The Tripura ESI Society authority may discontinue with an empanelled supplier without assigning any reason.
7. The pathological instruments, equipment's & chemicals bidders shall Deposit an earnest amount of **Rs. 15,000.00 (fifteen thousand)** only as security in favour of the Tripura Employees' State Insurance Society, through the demand draft/cheque drawn on PNB (Punjab National Bank), Kaman Chowmuhani branch, Agartala. This amount will be refundable and payable at the end of the agreed period of terms. However, in case of breach of agreed terms the security amount will be forfeited by the Tripura ESI Society authority.
8. The pathological chemical suppliers shall submit a copy of consent of the order duly Signed by him within 5 (Five) days from the date receipt of the correspondence as acceptance of the terms and agreement for continuation as a service provider under Tripura ESI Society, Agartala.
9. Rate excluding all taxes should be offer in prescribe format which to be collected from office of the CEO, Tripura ESI Society. GST or others taxes as applicable as per Govt. norms may be claimed, extra.
