SHORT RECITAL OF THE CASE

The President, Tripura Itt Bhatta Sramik Union affiliated to CITU has submitted 15 Point charter of demands on 08-11-2013 to the Labour Commissioner, Labour Directorate, Govt. of Tripura regarding revision of wages and other issues of the workers working in the **Brick Industry** in Tripura. The President and Vice-President, The Tripura Brick Manufacturers' Association have also submitted representations on the said issue. The Labour Commissioner (Conciliation Officer) has taken up the matter in conciliation proceeding. Accordingly, a tripartite meeting was invited on 20-12-2013 at 2.30 P.M. in the chamber of the Labour Commissioner, Labour Directorate, Agartala. During the meeting, both the representatives of workers' and employers' Associations briefed their problems and interacted with each other. After prolonged discussion, a settlement was arrived at with a new inclusion in regard to introduction of rates of wages of staff and workers working in the Brick Industry as per terms and conditions appended below :-

TERMS AND CONDITIONS OF THE SETTLEMENT

It is agreed by both the parties that the rate of wages in respect of moulding per 1,000 (one Thousand) only green bricks would be raised from **Rs. 400.00 to Rs. 540/-** in total consisting of the following items :-

3. It is also agreed that the Minimum Wages of official Staffs and Workers are as follows:-

- i) Manager/In-charge –Rs. 5,805.00 only per month inclusive of fooding etc.
- ii) Official Staffs – Rs. 4,050.00 only per month inclusive of fooding etc.
- iii) Existing Staffs enjoying higher wages shall get at least 35% hike in addition.

4. It is further agreed that the terms and conditions contained in this Memorandum of settlement would be effective from 1st December,2013 and will remain valid for 1(One) year from the date of effective.
