SCHEME FOR FINANCIAL ASSISTANCE FOR THE EDUCATION OF CHILDREN OF REGISTERED BENEFICIARY

Under the Provision of Rule 279 of the Building & Other Construction Workers (Regulation of Employment and Condition of Service) Rules 2001 and amended 2006 the scheme for Financial Assistance for the Education of the Children of the Registered Beneficiary is hereby made as follows :

6. **Name of the Scheme** : Scheme for Financial Assistance for the Education of the Children of a Registered Beneficiary.
7. **Eligibility** : Up to 02(two) children of a registered beneficiary reading in class-VI,VII,VIII,IX,X,XI,XII, ITI Courses (one year course & above), Technical Diploma, Paramedical Diploma, General Degree Master Degree, Technical Degree and other equivalent degree (as a regular student) will be eligible to get financial assistance under this scheme in an academic year.
8. **Object of the Scheme** : To give financial assistance to the children of a registered beneficiary reading in the above mentioned classes as a regular student for purchase of text books/school dresses in an academic year.
9. **How to apply** : The registered beneficiary will submit an application in a prescribed form for his child to the Secretary, Tripura Building & Other Construction Workers Welfare Board, Agartala through the District Labour Officer. The application should be supported by xerox copy of last marksheet of student, xerox copy of ration card last money receipt and identity card in Xerox of the registered beneficiary of the Tripura Building & Other Construction Workers Welfare Board. The certificate of the Head of Institution of School, College & University stating that the student is reading in which class during the year. **The application should be submitted not later than ending of 3 (three) months of respective academic year i.e. for TBSE application should be submitted upto 30th September..**

10. **Amount of Financial Assistance** : The amount of financial assistance that will be sanctioned by the TBOCWW Board to the children of the registered contraction workers is as follows :-

Class VI to VIII	₹1,000.00
Class IX to X	₹2,000.00
Class XI to XII	₹3,000.00
ITI Courses (one year & above courses)	₹3,000.00
Gen. Degree Course	₹5,000.00
Tec. Diploma & Paramedical Diploma	₹5,000.00
Gen. Master Degree	₹6,000.00
Tech. degree & other equivalent degree	₹8,000.00

ii) **Mode of Payment**: The payment should be made through the Tripura Gramin Bank (DBT) to the applicant Account Number.

11. **Ineligibility**: - If the student(s) is in service, they will not be eligible to get the education benefit under the said scheme of TB& OCWW Board.
