
**NOTIFICATION**

In continuation of this Department's Notification No.F.12(62)-LAB/ENF/IR/2012/4445-519 dated 6<sup>th</sup> July, 2019 and in furtherance of the aforesaid Notification, the State Government hereby revises the Variable Dearness Allowance (VDA) on the basis of 6-monthly average Consumer Price Index Numbers for three period commencing from 01-07-2019 to 31-12-2019, 01-01-2020 to 30-06-2020 and 01-07-2020 to 31-12-2020 on an average of increase in Consumer Price Index by **5076 over 4811** for various categories of workers engaged in "**Palatana Power Project**", Tripura as under and directs that the Variable Dearness Allowance shall be payable **with effect from 01-04-2021** by the employers to the workers/employees employed in the aforesaid employment as per the following schedule :


