NOTIFICATION

In continuation of this Department's Notification No.F.12(62)-LAB/ENF/IR/2012 /1372-87 dated 21st June, 2021 and in furtherance of the aforesaid Notification, the State Government hereby revises the Variable Dearness Allowance (VDA) on the basis of 6-monthly average Consumer Price Index Numbers for the period commencing from 01-01-2021 to 30-06-2021 on an average of increase in Consumer Price Index by **5176 over 5076** for various categories of workers engaged in "**Palatana Power Project**", Tripura as under and directs that the Variable Dearness Allowance shall be payable **with effect from 01-10--2021** by the employers to the workers/employees employed in the aforesaid employment as per the following schedule :
