

**SCHEME FOR FINANCIAL ASSISTANCE FOR MARRIAGE OF  
REGISTERED FEMALE CONSTRUCTION WORKERS AND DAUGHTER  
OF REGISTERED CONSTRUCTION WORKERS**

In accordance with the provision of sub-section (1) (h) of section 22 of Building & Other Construction Workers (R E & C S) Act, 1996 and the provision of Rule 282 (Other welfare measures) of the Tripura Building & Other Construction Workers (Regulation of Employment and Condition of Services) Rules 2001 and amended 2006, the scheme for financial assistance for marriage of female registered construction workers and daughters of registered construction workers are hereby made as follows

1. Name of the Scheme :- "Mahila Nirman Sramik Vivaha Yojana."
2. Eligibility :- The Registered construction worker who is a Registered Beneficiary for a period of not less than 1 (one) year continuously shall be eligible to get the benefit of Mahila Nirman Sramik Vivaha Yojana and the benefit shall not be applicable for marriage of daughters (of construction workers) who are in Government or Quasi-Government employment.
3. Object of the Scheme :- To give financial assistance to the registered female construction workers and daughters of registered construction workers for marriage purposes.

4. **How to apply :** The Registered construction worker should apply for the scheme of Mahila Nirman Sramik Vivaha Yojana as per prescribed Form No. XXXLI I (enclosed) before marriage. The application should be addressed to the Secretary, Tripura Building & Other Construction Workers Welfare Board, Office Lane, Agartala and submitted through District Chief Labour/Labour Officer. The application should be supported by the marriage invitation card of bride and groom side, other documents as proof of marriage and also copy of challan in respect of the last membership fee deposited.
5. **Amount of grant:-** Only female registered construction worker will get benefit of the amount of ₹ 10,000/- ( Rupees ten thousand) only as one time for her marriage in her life. The male and female registered construction workers will get @ ₹ 10,000/- ( Rupees ten thousand) only each up to maximum of their 2(two) daughters only in their lives .
6. **Mode of payment :-** After marriage the payment will be made by cheque through the District Labour Officer. In case , applicant prefers to receive the payment from the Board Office payment will be made to his /her personally. No authorization will be entertained.
