SHORT RECITAL OF THE CASE.

Sri Kanu Ghosh, General Secretary, Tripura Mill Sramik Union, CITU and 7(seven) others have submitted a representation to the Labour Commissioner, Labour Directorate, Agartala for enhancement of wages for the workers engaged in the employment of Rice Mills. Accordingly, a tripartite meeting is held on 07-08-2013 at 3-00 p.m. in the chamber of the Labour Commissioner for the said purpose. After prolonged discussion with the employers' and workers' representatives, the matter has been settled amicably on the following terms & conditions.


