



NOTICE INVITING FOR EXPRESSION OF INTEREST



1. The vehicle should manufactured by Mahindra & Mahindra Ltd. and run by diesel fuel made not before 2018.
2. The vehicle should bear the commercial registration & Road permit.
3. The driver of the vehicle should have the commercial driving license & shall be provide by the owner.
4. The copies of tax clearness. IT clearance of the owner of vehicle should be kept in the vehicle.
5. The vehicle should possess the logbook.
6. No detention charge would be allowed for Sunday/Holiday if the vehicle is not utilized on these days eligible.
7. The successful tender shall furnish updated copies of Registration Certificate/ Fitness certificate/ Road Tax certificate / Insurance etc. certificate/ Income Tax/ Professional Tax clearance certificate at the time of execution of agreement.
8. GST & Income Tax will be deducted from the bill as per provisions of relevant Act. & Rules.
