In continuation of this Department's Notification No.F. 12(62)- LAB/ENF/IR/2012/7095-115 dated 11<sup>th</sup> May, 2017 and in furtherance of the aforesaid Notification, the State Government hereby revises the Variable Dearness Allowance (VDA) on the basis of 6-monthly average Consumer Price Index Numbers for the period of six months commencing from 01-01-2017 and ending on 30-06-2017 over the previous 6-monthly average viz 4515.17 over 4385 average Consumer Price Index for different categories of workers engaged in the employment of " Palatana Power Project " in Tripura as under and directs that the Variable Dearness Allowance shall be payable with effect from 01-10-2017 by the employers to the workers/employees employed in the aforesaid employment as per the following schedule :
