## CORRIGENDUM

In exercise of powers conferred under Section 4(2) of the Tripura Shops and Establishments Act,1970 read with Rule, 29 of Tripura Shops and Establishments Rules 1970, the exemption from operation of Section 5(1), section6(1) and Section 4 of the Tripura Shops and Establishments Act,1970 was allowed for all shops and establishments in the State for different occasions and periods vide this Department Notification even No. dated 9th April,2018. In that Notification at Sl No. 19, a total of 17(seventeen) days starting from 08/10/2018 to 24/10/2018 was allowed for exemption for the occasions of Mahalaya/Durga Puja, Gandhi Birthday/Laxmi Puja etc.

- 2. As requested by all Tripura Merchants' Association vide its letter dated 20/09/2018, the Government has considered to allow all the Shops and establishments to remain open from 29/09/2018 instead of 08/10/2018 for the aforesaid occasions/periods as notified.
- 3. After careful examination of the matter, the Government has considered the proposal and hereby modifies the said occasions/periods as indicated below.
