NOTIFICATION

In continuation of this Department's Notification No.F.12(62)-LAB/ENF/IR/2012/568-642 dated 28th January, 2019 and in furtherance of the aforesaid Notification, the State Government hereby revises the Variable Dearness Allowance (VDA) on the basis of 6-monthly average Consumer Price Index Numbers for the period of six months commencing from 01-07-2018 and ending on 31-12-2018 over the previous 6-monthly average viz **4811 over 4736** average Consumer Price Index for different categories of workers engaged in the employment of " **Palatana Power Project** " in Tripura as under and directs that the Variable Dearness Allowance shall be payable **with effect from 01-04-2019** by the employers to the workers/employees employed in the aforesaid employment as per the following schedule :
