SCHEME FOR PENSION TO THE REGISTERED CONSTRUCTION WORKERS

In accordance with the provision of Section 22(1)(b) of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996 and Rule 276 of the Tripura Building & Other Construction Workers (Regulation of Employment and Conditions of Service) Rules, 2001, the scheme for payment of Pension to a Registered Construction Worker who has completed age of 60 (sixty) years.

1. **Name of Scheme** :-

Pension to the Registered Construction Workers who have completed the age of 60 (sixty) years.

2. **Eligibility** :-

A Registered Construction Worker who has been depositing monthly subscription for not less than 5 (five) years continuously after the registration as a beneficiary under the scheme shall be eligible for pension on completion of 60 (sixty) years of age. The pension will be payable from the 1st day of the succeeding month in which he/she completes 60 (sixty) years of age.

3. **Object of Scheme**:-


To provide financial assistance to the registered beneficiary who has retired due to old age attaining 60 (sixty) years.

4. **How to apply** :-

Application for pension shall be submitted in Form XXXVII in duplicate to the Secretary of the Tripura Building & Other Construction Workers Welfare Board through concerned District Labour Officer along with the age proof supporting documents.

5. **Amount of Pension** :-

The amount of Pension shall be ₹500/- (Rupees five hundred) only per month will be paid till death of the Pensioner.

6. Mode of Payment :-

Pension money will be electronically transferred to the pension holders accounts in any Branch of Tripura Gramin Bank.

7. Condition for:-

The live certificate to be attested by a Gazetted drawal of Pension Officer, has to be furnished on 1st April of every year by the pensioner.
